Here's how it works:

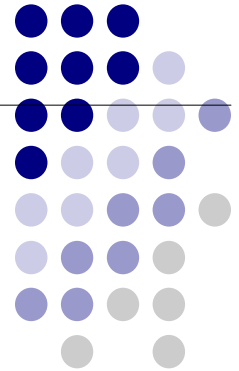
Your company can purchase a Breakfast Meeting Coupon Book for \$100 from the MMA office. The book will contain "coupons" for 5 Breakfast Meetings. Invite five clients to one Breakfast Meeting or invite five different clients to the Breakfast Meeting of their choice—it's up to YOU!

To redeem a Breakfast Meeting Coupon, the coupon holder must simply complete a registration form (found at mnamb.org), and mail it with their coupon to the MMA office. It's that simple.

Coupons are valid for one year from the date of purchase, and are NOT valid for the June Legislative Update Breakfast Meeting. Once a coupon has been submitted with registration for a Breakfast Meeting, that coupon is considered void—no exceptions.

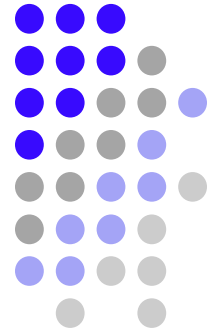

Breakfast Meeting Coupon Book Terms and Conditions



- Companies may purchase as many coupon books as they would like from the MMA office. Coupon Book order forms are available at www.mnamb.org, at the MMA office, or at any breakfast meeting.
- Coupons are sold in books of five for \$100, so companies are paying for four meetings and getting one free.
- Each coupon entitles the holder to ONE (1) paid admission to attend the MMA Breakfast Meeting of their choice on or before the expiration date on the coupon.
- Coupons are not redeemable for the June Breakfast Meeting / Legislative Update.
- Breakfast Meeting coupons are valid for one year from the date of purchase. No refunds or exchanges will be made for coupons not redeemed.
- To redeem a coupon, the coupon must be mailed to the MMA office along with a completed Breakfast Meeting registration form.
- Once a coupon holder has registered to attend a Breakfast Meeting by completing and submitting a Breakfast Meeting registration form to the MMA office, that coupon is considered void and may not be used again or transferred for use at a later Breakfast Meeting.

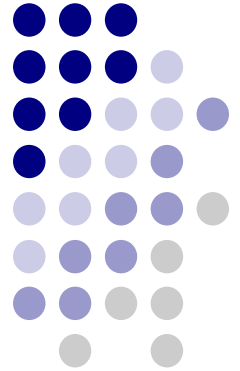
